RESOLUTION NUMBER 2013-314

A RESOLUTION OF THE COMMON COUNCIL OF THE CITY OF MARTINSVILLE, INDIANA APPROVING THE STORMWATER RATE AND IMPLEMENTATION OF STORMWATER USER FEES BASED ON EQUIVALENT RESIDENTIAL UNITS (ERUs) AS ADOPTED BY THE BOARD OF PUBLIC WORKS AND SAFETY.

WHEREAS, the City of Martinsville, Indiana (the "City") has established a Stormwater Department pursuant to IC 8-1.5-5 and that per Ordinance 2013-1680 management and control of the Stormwater Department was placed under the Board of Public Works and Safety (the "Board"); and

WHEREAS, the Board has held a public hearing and adopted a policy for implementation, administration and collection of stormwater fees based on Equivalent Residential Units (ERUs) as set forth in Resolution No. 2013-312 and established a stormwater rate per EDU per Resolution No. 2013-313 and, whereas both resolutions were adopted and approved by the Board on October 21, 2013 (the "Resolutions"); and

WHEREAS, the stormwater rate is required to be approved by the Common Council prior to taking effect pursuant to IC 8-1.5-5-7; and

WHEREAS, the Common Council now desires to approve the Board policy for implementation, administration and collection stormwater user fees to be based on Equivalent Residential Units (ERUs) and further approve the stormwater rate per EDU as adopted by the Board.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMON COUNCIL OF THE CITY OF MARTINSVILLE, INDIANA THAT:

Section 1. That Resolution No. 2013-312 and Resolution No. 2013-313 as adopted by the Board are hereby approved.

Section 2. Per Board Resolution No. 2013-313 the stormwater rate for one (1) ERU is \$2.25 per month. Further, stormwater rates and fee shall be implemented, administrated and collected based on Equivalent Residential Units (ERUs) per Resolution No. 2013-312 of the Board.

Section 3. The Resolutions shall be effective upon adoption.
