PRE-TRIAL DEFERRAL PROGRAM

Please go to www.morganprosecutor.com to apply for the deferral program. Please read all directions carefully. If you do not have access to a computer, you can call 765-342-1050 to speak with the deferral coordinator

PLEASE NOTE: YOU WILL EITHER PAY THE AMOUNT OWED FOR THE CITATION **OR** YOU WILL PAY THE DEFERRAL FEE. **YOU DO NOT PAY BOTH.**

FINE AND COST SCHEDULE – Below you will find the amount you owe. This schedule is a guideline and is subject to change. Any fines paid after the due/court date, is subject to a \$25 late fee. You may request 1 extension. Any additional extension will result in a one time \$25 fee being added.

Martinsville City Court is a part-time court. Do not expect court personnel to be available at your convenience. Not contacting the court is not an excuse for not appearing in court on the date given when you received your citation or when you bonded out of jail.

If you fail to appear, you will be charged additional late fees, a warrant may be issued for your arrest and/or you may be suspended by the BMV.
